## ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00450 on 02.11.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref No. ICSOI/R/E/23/24280 dated 11.10.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his application dated 16.09.2023 has requested to provide the following information:
  - 1. A list of all the candidates recruited for the post of CRC executives (contractual) for working at CRC Manesar in the year 2023 (till date).
  - 2. The monthly remuneration of all the CRC executives (contractual) for working at CRC Manesar recruited in the year 2023 (till date).
- (3) The Appellant has informed in the instant appeal that "Refused access to information requested".
- (4) The reply of the Respondent against the instant appeal is as under: -

"Our reply remains the same as provided in RTI Reply dated 11.10.2023.

Since the information as sought by applicant (appellant herein) is relating to the third party, therefore, as per the provisions of the RTI Act, 2005, the information pertaining to third party was declined and exempted under section 8(1)(j) of the RTI Act, 2005

Therefore, the contents made in the RTI Reply stands as it is and the appeal deserves to be dismissed".

(5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

The Office concurs with the submission of the Respondent.

The appeal is accordingly disposed of.
