## ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00050 on 16.03.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/01604 dated 13.03.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.

"It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in her RTI Application ICSOI/R/E/23/01604 dated 26.02.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 10.03.2023 and once again on 06.04.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

Further, the date of accessing the scanned copies has also been extended till 20.04.2023.

The contents as above made in the RTI reply stands as it is and are candid".

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) This Office concurs with the submission of the Respondent. Response provided by CPIO EXAM to the Appellant to access the information sought vide email dated 10.03.2023 and once again on 06.04.2023 & also date extended till 20.04.2023 for accessing the scanned copies. Appellant is requested to check her registered email ID.

The appeal is accordingly disposed of.
