ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00053 on 16.03.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. Further, the date of accessing the scanned copies has also been extended till 20.04.2023.

- (6) This Office concurs with the submission of the Respondent. Response provided by CPIO EXAM to the Appellant to access the information sought vide email dated 14.03.2023 and once again on 06.04.2023 & also date extended till 20.04.2023 for accessing the scanned copies. Appellant is requested to check his registered email ID.

The appeal is accordingly disposed of.
