ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00055 on 17.03.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/03180 dated 17.03.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his application dated 27.02.2023 has requested to provide the photocopy of answer book of CS Professional Programme Examination (New Syllabus) session: December 2022 for the Subjects: 434 Secretarial Audit, Compliance management and Due Diligence, 435 Corporate Restructuring, Insolvency, Liquidation and winding up, 436 Resolution of Corporate Disputes, Non-Compliances and Remedies.
- (3) The Appellant has informed in the instant appeals that "Details not provided".
- (4) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/23/03180 dated 27.02.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 15.03.2023 and once again on 06.04.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

Further, the date of accessing the scanned copies has also been extended till 20.04.2023.

The contents as above made in the RTI reply stands as it is and are candid".

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) This Office concurs with the submission of the Respondent. Response provided by CPIO EXAM to the Appellant to access the information sought vide email dated 15.03.2023 and once again on 06.04.2023 & also date extended till 20.04.2023 for accessing the scanned copies. Appellant is requested to check his registered email ID.

The appeal is accordingly disposed of.
