- (1) The Appellant has filed the first Appeal- No. ICSOI/A/E/23/00066 on 18.03.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. - (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) This Office concurs with the submission of the Respondent. Response provided by CPIO EXAM to the Appellant to access the information sought to vide email dated 14.03.2023 and once again on 06.04.2023 & also date extended till 20.04.2023 for accessing the scanned copies. The appellant is requested to check his registered email ID.

The appeal is accordingly disposed of.
