ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00067 on 18.03.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/02270 dated 15.03.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide her application dated 26.02.2023 has requested to provide the answer sheets for CS Professional Programme Examination-December 2022 for the subjects: 1 SECRETARIAL AUDIT, COMPLIANCE MANAGEMENT AND DUE DILIGENCE (SACMDD CODE 434 Paper 2: CORPORATE RESTRUCTURING, INSOLVENCY LIQUIDATION AND WINDING-UP CRILW CODE 435 Paper 3: RESOLUTION OF CORPORATE DISPUTES NONCOMPLIANCES AND REMEDIES RCDNR CODE 436.
- (3) The Appellant has informed in the instant appeals that "Refused access to Information Requested".
- (4) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in her RTI Application ICSOI/R/E/23/02270 dated 26.02.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 14.03.2023 and once again on 06.04.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

Further, the date of accessing the scanned copies has also been extended till 20.04.2023.

The contents as above made in the RTI reply stands as it is and are candid”

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) This Office concurs with the submission of the Respondent. Response provided by CPIO EXAM to the Appellant to access the information sought vide email dated 14.03.2023 and once again on 06.04.2023 & also date extended till 20.04.2023 for accessing the scanned copies. The appellant is requested to check her registered email ID.

The appeal is accordingly disposed of.
