**ORDER**

1. The Appellant has filed first appeal on 17.09.2022 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No: Registration Number: ICSOI/R/E/22/09000 dated 17.09.2022 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
2. The Appellant vide her application dated 31.08.2022 has requested to provide certified copies of Executive Programme for June 2022 attempt.
3. The Appellant has informed in the instant appeals that "Refused access to Information Requested".
4. The reply of the Respondent against the instant appeal is as under: -

"It is submitted that we have provided the requisite information/documents as sought by the Applicant (Appellant hereinafter) in her RTI Application ICSOI/R/E/22/09000 dated 31.08.2022, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 16.09.2022 in which a web-link, Username and Password have been provided to the RTI Appellant to download and view the requisite Answer Books.

Further, the Appellant acknowledged the receipt of information sought vide email dated 06.10.2022.

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine.”

5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
6. The Office concurs with the submission of the Respondent. It has been observed that information was provided to the Appellant vide email dated 16.09.2022. Further, vide email dated 06.10.2022, Appellant has confirmed the receiving of certified copies.

The appeal is accordingly disposed of.
