ORDER

- The Appellant has filed first appeal on 19.09.2022 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No: Registration Number: ICSOI/R/E/22/07566 dated 19.09.2022 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- 2. The Appellant vide her application dated 28.08.2022 has requested to provide answer sheets.
- 3. The Appellant has informed in the instant appeals that "Refused access to Information Requested" & requested to provide answer scripts for Executive Programme.
- 4. The reply of the Respondent against the instant appeal is as under: -

"It is submitted that the applicant (Appellant hereafter) did not provide the details inter alia including Roll Number and/ or Registration Number necessary for providing copy of Answer Books in her RTI Application no. ICSOI/R/E/22/07566 dated 28.08.2022. Now, the Appellant submitted copy of her admit card in her above mentioned Appeal and accordingly the information sought has been provided to the Appellant at her email id registered with the ICSI vide email dated 07.10.2022.

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine."

- 5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- 6. The Office concurs with the submission of the Respondent. It has been observed that information was provided to the Appellant vide email dated 07.10.2022 at registered email id wherein it is mentioned that "information sought by you will remain hosted at the given link till 28-Oct-2022".

The appeal is accordingly disposed of.
