**ORDER**

- (a) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00091 on 21.03.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/04213 dated 20.03.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (b) The Appellant vide his application dated 28.02.2023 has requested to provide answer sheets for 01 JURISPRUDENCE, INTERPRETATION AND GENERAL LAWS 02 COMPANY LAW 03 SETTING UP OF BUSINESS ENTITIES AND CLOSURE 04 TAX LAWS held in December 2022.
- (c) The Appellant has informed in the instant appeals that "Details not provided".
- (d) The reply of the Respondent against the instant appeal is as under: -

"1. It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in her RTI Application ICSOI/R/E/23/04213 dated 28.02.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 20.03.2023 and once again on 10.04.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

2. The Appellant has filed multiple appeals, as above, i.e. ICSOI/A/E/23/00089, ICSOI/A/E/23/00090, ICSOI/A/E/23/00091 and ICSOI/A/E/23/00092 against her RTI Application No. ICSOI/R/E/23/04213 dated 28.02.2023 on the same matter and all the same may kindly be considered in the instant response by the respondent.

3. It is further submitted that in the instant Appeals, the Appellant has expressed her dissatisfaction on marks awarded to her and sought clarification on her own analysis on the information supplied which is 'not an information' under the provisions of the RTI, Act 2005.

The contents as above made in the RTI reply stands as it is and are candid".

- (e) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (f) This Office concurs with the submission of the Respondent. Response provided by CPIO EXAM to the Appellant to access the information sought vide email dated 20.03.2023 and once again on 10.04.2023 & also date extended till 20.04.2023 for accessing the scanned copies. Appellant is requested to check her registered email ID.

The appeal is accordingly disposed of.
