ORDER

- (a) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00096 on 22.03.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/04329 dated 22.03.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (b) The Appellant vide his application dated 28.02.2023 has requested to provide copies of answer sheets of all 6 subjects of group 2 and 3 for CS Professional Programme examination, Session: December ,2022
- (c) The Appellant has informed in the instant appeals that "Details not provided".
- (d) The reply of the Respondent against the instant appeal is as under: -

"1. It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/23/04329 dated 28.02.2023, was ambiguous and incomplete as the same was not containing required credentials i.e. Roll No./Registration No./Copy of admit card and was disposed of accordingly and informed to the Appellant vide letter dated 22.03.2023"

2. It is further submitted that the Appellant has now provided the requisite credentials in this instant Appeal and thus, the CPIO is of the view that the information sought can be provided and hence the information sought has been provided to the Appellant vide email dated 13.04.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

The contents as above made in the RTI reply stands as it is and are candid”.

- (e) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (f) This Office concurs with the submission of the Respondent. Response provided by CPIO EXAM to the Appellant to access the information sought vide email dated 13.03.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought. Appellant is requested to check his registered email ID.

The appeal is accordingly disposed of.
