ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00097 on 23.03.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/03478 dated 22.03.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide her application dated 27.02.2023 has requested to provide certified copy of answer for the session December 2022 Examination.
- (3) The Appellant has informed in the instant appeals that "Provided Incomplete, Misleading or False Information".
- (4) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that requisite information as sought by the Applicant (Appellant hereinafter) in her RTI Application ICSOI/R/E/23/03478 dated 27.02.2023 was ambiguous and incomplete as the same was not containing required credentials i.e. Roll Number/Registration number/ copy of admit card and was disposed of accordingly and informed to the Appellant vide letter dated 22.03.2023"

It is further submitted that the Appellant has now provided the requisite credentials in this instant Appeal and thus, the CPIO is of the view that the information sought can be provided and hence the information sought has been provided to the Appellant vide email dated 13.04.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought

The contents as above made in the RTI reply stands as it is and are candid”.

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) This Office concurs with the submission of the Respondent. Response provided by CPIO EXAM to the Appellant to access the information sought vide email dated 13.04.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought. Appellant is requested to check her registered email ID.

The appeal is accordingly disposed of.
