ORDER

- (1) The Appellant has filed first Appeal dated 10/05/2026 under Section 19(1) of the Right to Information Act, 2005 in connection with Response vide letter dated 10/04/2026 against the Central Public Information Officer (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his RTI Application dated 23/03/2026 has requested the following information:

1. भारतीय कम्पनी सचिव संस्थान ने एस0बी0सी0 एक्सपोर्ट लि0, 49/95, साइड-4, साहिबाबाद इण्डस्ट्रीयल एरिया गाजियाबाद उ0प्र0 (पिन-201010) को संविदा के आधार पर कर्मचारियों के नियुक्ति के लिए निर्धारित किया है। भारतीय कम्पनी सचिव संस्थान द्वारा एस0बी0सी0 एक्सपोर्ट लि0 के लिए प्रति कर्मचारी के लिए कितना मानदेय निर्धारित किया है, उसकी सत्यापित सूची उपलब्ध करायी जावे।
2. उपरोक्त संस्थान द्वारा एस0बी0सी0 एक्सपोर्ट लिमिटेड को कौन से पदों पर संविदा कर्मचारियों की नियुक्ति कर सकता है अलग-अलग पदों के प्रति कर्मचारी मानदेय सहित सूची उपलब्ध करायी जावे।

3. उपरोक्त संस्थान द्वारा एस0वी0सी0 एक्सपोर्ट द्वारा संविदा पर लिपिक, चपरासी का मानदेय व उनको दी जाने वाली सुविधा कितना निर्धारित की गयी है उसकी सूची उपलब्ध करायी जावे।

(3) The reply of the Respondent against the instant appeal is as under: -

"Since the RTI application pertains to Directorate of HR of the ICSI, therefore, the CPIO has asked for written submission from concerned Directorate for the same. Their submission is mentioned below:

"The information sought by the applicant (appellant herein) is personal in nature, the disclosure of which has no relationship to any public activity or interest and falls under fiduciary relationship. Therefore, the disclosure of such information is exempted U/S 8(1)(e) and 8(1)(j) of the Right to Information Act, 2005.

In view thereof, we reiterate our earlier reply."

(4) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

This office concurs with the submissions of the Respondent in his reply to the instant appeal.

The appeal is accordingly disposed of.
