
**ORDER**

1. The Appellant has filed first appeal on 16<sup>th</sup> January, 2020 under section 19(1) of the Right to Information Act, 2005 against response issued vide letter Ref. No. RTI 2005/2913(19) dated 13.12.2019 by the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
2. The Appellant vide his application dated 18.11.2019 had requested to provide certain information pertaining to 45<sup>th</sup>, 46<sup>th</sup> and 47<sup>th</sup> National Convention of Company Secretaries.
3. The Respondent vide letter dated 13.12.2020 issued the response to the Appellant. In the said response, the Respondent had informed the Appellant that the information pertaining to 47<sup>th</sup> National Convention of Company Secretaries is under finalization.
4. The Appellant has informed in the instant appeal as under :

*"No information has been given from your office about the 47th national convention by saying that it is under finalization. But as on this appeal date it's almost 2 months has been passed after 47th the convention.*


*So as on today the information regarding 47th convention should be finished and made be available to the applicant."*

5. The Respondent has informed against the instant appeal that the reply earlier provided is reiterated. The Respondent has also mentioned that the reply against RTI application was issued on 13.12.2019 and the first appeal dated 16.01.2020 has been received after the stipulated period under the RTI Act.
6. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
7. This Office concurs with the submissions of the Respondent.
