ORDER

- The Appellant has filed first appeal dated 5th April 2019 under section 19(1) of the Right to Information Act, 2005 against information provided vide letter Ref. No. RTI 2005/2223(19) dated 2nd April, 2019 by the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- 2. In this appeal, the Appellant has informed that the Respondent has provided incomplete, misleading or false information.
- 3. The Appellant, against point No. 2, has submitted that the eligibility criteria for recruitment was fixed by the ICSI.
- 4. The Appellant, against point No.4, has submitted that the ICSI has not shared the data regarding highest and lowest package offered in each placement.
- The Appellant, against point No. 6, has submitted that the ICSI has not provided the current status about the eligibility of persons having CS qualification to appear in UGC NET examination.
- 6. The Appellant, against point No. 7 and 8, has submitted that the ICSI should have the information regarding the Banks and other Government Financial institutions.

- 6. The Respondent, against point No. 2, has submitted that the information relating to step taken by the ICSI to provide opportunity to its member for the Employment in Government Sector/ Government Companies has been provided. The Respondent has further submitted that the Appellant is seeking fresh information in the appeal.
- 7. The Respondent, against point No. 4, has submitted that the information related to the data regarding highest and lowest package offered in each placement is not maintained in the form/content as desired and therefore not available.
- 8. The Respondent, against point No. 6, has submitted that the information against the query as raised by the Appellant has been provided and the Appellant is seeking fresh information the appeal.
- 9. The Respondent, against point No. 7 and 8, has submitted that the requisite information is not available with ICSI and as per the RTI Act, the public authority is not meant to create information, or to interpret information; only such information can be provided which already exists with the public authority.
- 10. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- 11. This Office concurs with the submissions of the Respondent.

The appeal is accordingly dismissed.
