

**ORDER**

1. The Appellant has filed first appeal dated 12<sup>th</sup> September, 2019 under section 19(1) of the Right to Information Act, 2005 against information provided vide letter Ref. No. RTI 2005/2329(19) dated 2<sup>nd</sup> September, 2019 by the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
2. The Appellant had submitted an application under the RTI Act wherein he submitted that "I appeared for CS Executive (Old Syllabus) examination in June, 2019 exams. I want suggested answer of all 7 (soft copy) subjects prepared by ICSI so I can prepared for my next examinations."
3. The Respondent had informed against the RTI application that the Institute currently does not publish Suggested Answers neither in soft copy nor in printed form for students. Hence Suggested Answers of all 7 (soft copy) subjects can not be provided.



4. The Respondent further advised to the Appellant to procure Guideline Answers being published by the Institute by following the due procedure i.e. buying from ICSI Sale Counter at any ICSI Office.
5. In the instant appeal, the Appellant has requested the Respondent to send him Guideline Answers for CS Executive (Old Syllabus) June, 2019 attempt.
6. The Respondent has informed against the instant appeal that the earlier reply is reiterated.
7. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
8. This Office concurs with the submissions of the Respondent.

The appeal is accordingly dismissed.
