ORDER

- 1. The Appellant has filed first appeal on 13.04.2021 under Section 19(1) of the Right to Information Act, 2005 in connection with query Ref. No. RTI 2005/5041(21) dated 13.04.2021 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- 2. The Appellant vide his application dated 16.03.2021 has requested to provide information through RTI.
- 3. The Appellant has informed in the instant appeals that "Refused access to Information Requested".
- 4. The reply of the Respondent against the instant appeal is as under:-

"The reply given earlier is reiterated as the information sought cannot be provided as the same has no relationship with any public activity or interest. Please refer the Para 12 of the order issued in the matter of W.P.(C) 7976/2020 dated 12.01.2021 of Hon'ble High Court of Delhi.

However, the relevant information which was required to be conveyed to the applicant i.e. Mr. Sharad Kumar Jhunjhunwala has already been provided through Email dated 02.07.2015 and the same has also been mentioned in RTI reply.

It is also necessary to mention that the RTI applicant (appellant herein) is a habitual RTI applicant and seeking endlessly many kind of information relating to the

Institute, employees and stakeholders of the Institute. (Please refer our earlier written submissions and order issued by Hon'ble First Appellate Authority).

We prayed before Hon'ble Appellate Authority to consider the above-mentioned order issued by Hon'ble High Court of Delhi as the RTI applicant is seeking the information for his personal objectives and there is no public activity or interest is involved.

In view of the foregoing, the information cannot be provided and therefore, the appeal deserves to be dismissed in-limine."

- 5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- 6. This Office concurs with the submissions of the Respondent.

The appeal is accordingly dismissed.
