ORDER

- The Appellant has filed first appeal on 24.11.2021 under Section 19(1) of the Right to Information Act, 2005 in connection with query Ref. No. RTI ICSOI/R/E/21/03364 dated 15.10.2021 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- 2. The Appellant vide his application dated 15.10.2021 has requested to provide scan copy of answer sheet of 2nd group of Executive Progromme.
- 3. The Appellant has informed in the instant appeals that "I have filed application on 15 October 2021 for exam papers from institute of company secretary of India for cs-executive course and last mail which was I received was request has been disposed of after that I didn't received any from and exam paper till now please look into my request as soon as possible."
- 4. The reply of the Respondent against the instant appeal is as under: -

"This is to inform that we have provided the requisite information/documents on 03.11.2021 in which a web-link, Username and Password has been provided to the RTI applicant (appellant herein above) to download and view the answer copies. Further, the said information was once again provided to the applicant vide email dated 24.11.2021.

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine."

- 5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- 6. The submissions of the Respondent is taken on record. It is directed that in case, the user name & password as emailed, has not been received, the appellant may approach the respondent within 03 days of issue of this order. It is further directed to the respondent that if approached again the respondent to share the document by email within 7 days of being approached.

The appeal is accordingly disposed of.
