**ORDER**

1. The Appellant has filed first appeal on 14.06.2021 under Section 19(1) of the Right to Information Act, 2005 in connection with query Ref. No. RTI 2005/5089/(21) dated 14.06.2021 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
2. The Appellant vide his application dated 04.06.2021 has requested to provide information through RTI.
3. The Appellant has informed in the instant appeals that "Provided Incomplete, Misleading or False Information".
4. The reply of the Respondent against the instant appeal is as under: -
