**ORDER**

1. The Appellant has filed first appeal on 19.07.2021 under Section 19(1) of the Right to Information Act, 2005 in connection with query Ref. No. RTI 2005/5111/(21) dated 19.07.2021 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.

RTI Reply from CPIO: "Individual details like Name, membership number, certificate of practice number, organization's name, email id, mobile number, address etc. of any particular current member are available on the ICSI website at the link <https://www.icsi.in/student/Members/MemberSearch.aspx>

Further, one can purchase the CD of list of members @ Rs. 590/- (for non-members including 18% GST) and @ Rs. 295/- (for members including 18% GST). No other form is maintained to avoid misuse."

2. The Appellant vide his application dated 13.07.2021 has requested to provide information through RTI.
3. The Appellant has informed in the instant appeals that "Details not provided".
4. The reply of the Respondent against the instant appeal is as under:-

“The appellant has not raised any new ground in his 1st appeal against the reply provided, therefore, the reply is reiterated.

In view of the foregoing, we reiterate our earlier reply and therefore, the appeal deserves to be dismissed in-limine.”

5. This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
6. This Office concurs with the submission of the Respondent.

The appeal is accordingly disposed of.
