**ORDER**

1. The Appellant has filed first appeal on 20.09.2021 under Section 19(1) of the Right to Information Act, 2005 in connection with response Ref. No. RTI 2005/5135(21) dated 20.09.2021 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
2. The Appellant vide his application dated 09.09.2021 has requested to provide information through RTI.
3. The Appellant has informed in the instant appeals that "The location has not been provided. PIO stated that the information is hosted on website. Please ask the PIO to give the exact address where the requisite information is hosted."
4. The reply of the Respondent against the instant appeal is as under:-

"It appears that the Appellant has filed captioned appeal without going through and exploring the ICSI's website for the desired information as informed to him vide RTI Reply dated 20.09.2021.
