## Highlights of the Scheme

1. Fee Waiver scheme of the Institute of Company Secretaries of India is applicable for all the students registering for the Foundation or Executive Programme Stages from North Eastern States (Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim and Tripura) and State of Jammu and Kashmir. All students belonging to North Eastern States and State of Jammu and Kashmir who have passed the 10+2 or equivalent or Bachelor's Degree or equivalent irrespective of the percentage of marks shall be eligible for Fee Waiver while registering for Foundation Programme or Executive Programme Stage respectively. Under this scheme students shall be getting fee waiver in registration fees in case they register for Foundation or Executive stage as the case may be.
2. The Students registered under this scheme are required to apply online without remitting any registration fees.

## Benefits of the Scheme

1. In line with the policy of Government of India for inclusive growth of all parts of the country, the Institute has formulated a limited time Fee Waiver Scheme for the students from Jammu & Kashmir and North Eastern States.
2. In a rare opportunity, the students belonging to and residing in these States are being granted waiver of Fee for registration to the CS Foundation Programme and CS Executive Programme Stage for a limited period.
3. The aim of the Fee Waiver Scheme is to promote excellence and empowerment of the youth of the North Eastern States and the State of Jammu & Kashmir.

**CS Foundation Programme** : 10+2 pass or equivalent

**CS Executive Programme** : CS Foundation pass/Graduates of any stream except (Fine Arts or equivalent) may seek registration to the Executive Programme.
