#### **REGISTRAR OF COMPANIES**

Dr. S Muralidhar, J 31<sup>st</sup> January, 2008

#### ISSUE(S) INVOLVED:

Managerial remuneration – Determination of Net Profits for purposes of computation of – unprovided depreciation of earlier years / arrears of depreciation of earlier years, how far required to be deducted for the purposes of computation of managerial remuneration – Section 198, 349 and 350.

#### **DECISION**

The unprovided depreciation of the previous years does not fall within the purview of 'excess expenditure' in clause (I) of sub-section (4) of Section 349. The Language of sub-section (4), which details the specific heads of deduction for arriving at the net profit, clearly contemplates 'depreciation' in clause (k) as separate and distinct from an item of excess 'expenditure' in clause (1). Had Parliament intended to include unprovided depreciation of the previous years as one other head of deduction, it would have so provided or at least included it in clause (k) itself. The intent, therefore, appears to be not to include unprovided depreciation of the previous years as a head of deduction and restrict the deduction to depreciation for the year in question in terms of Section 350. Nothing in the language of clause (1) of sub-section (4) of section 349 appears to indicate that it is some kind of a catch- all residuary clause which can accommodate all heads of deduction not elsewhere specified in the said sub-section (4).

#### SATISH PRABHAKAR PADHYE AND OTHERS

Shri R V Raveendran, R M Lodha & C K Prasad, JJ 31<sup>st</sup> March, 2010

#### <u>ISSUE(S) INVOLVED:</u>

Formation of Company – Whether a Company owes its existence to the Act – Section 12 (1).

### **DECISION**

A 'Company' is not 'established' under the Act. An incorporated Company does not 'owe' its existence to the Act. An incorporated Company is formed by the act of any seven or more persons (or two or more persons for a Private Company) associated for any lawful purpose subscribing their names to the memorandum of Association and by complying with the requirements of the Act in respect of registration. A 'Company' is incorporated and registered under the Act and not established under the Act.

#### **ISSUE(S) INVOLVED:**

Name of Company – Application for rectification by registered Proprietor of trade made by deletion of word 'Technova' from its name – Limitation period prescribed under unamended Section 22 expired – Could subsequent amendment of Section 22 enlarging the period of limitation revive the rights which had already become barred by limitation – Section 22.

#### **DECISION**

Where the Petitioner Company contested the Order of the Regional Director directing it to delete the word 'Technova' from its name on an application filed by second respondent under Section 22 on the ground that it had been using the name for almost nine years and the period of limitation prescribed under Section 22, prior to the amendment of sub-section (1) in the year 2000 by the Trade Mark Act, 1999, having expired, a subsequent amendment enlarging the period of limitation could not revive the rights which had already become barred by limitation as a result of which remedy of the second respondent would become barred under the unamended



provision of Section 22 and it could not as a proprietor of a registered trade mark claim an extended period of limitation under proviso to clause (ii) of sub-section (1) of Section 22.

SINTEX INDUSTRIES LTD., In re.

Shri K M Thaker, J 4<sup>th</sup> March, 2009

#### ISSUE(S) INVOLVED:

Arrangement – Court's sanction to Scheme – Consequences of alleged breach of Section 295 – How far dissuade Court from sanctioning Scheme of Arrangement – Section 391.

#### **DECISION**

In the instant case the Regional Director objected to the Scheme of Amalgamation on the ground that there had been a contravention of the provisions of Section 295 of the Companies Act, 1956 as such the Directors have vacated the office and the decision of the Board approving amalgamation was improper and invalid. It was found that despite vacancy in the Board the resolution was approved by requisite majority. The court observed that once it is found that the resolution by the Board of Directors is valid and the alleged vacancy in the Board of directors would not invalidate the resolution, then as a corollary the subsequent actions, including the acceptance and approval of the Scheme by majority of Shareholders, would also be valid. Where the resolution is passed by statutory majority in accordance with sub-section (2) of Section 391 without coercion and undue influence, the object as well as the terms of the Scheme are reasonable as found by the Shareholders in their collective and commercial wisdom and the Scheme is not found to be against the interest of the Company or the Shareholders, there would be no legal impediment in sanctioning the Scheme, which would not, however, give any immunity to the Company or to the directors from any proceeding including prosecution already initiated or likely to be initiated.

#### GOVERNMENT OF NATIONAL CAPITAL TERRITORY OF DELHI

Ms. Gita Mittal, J December, 2009

#### ISSUE(S) INVOLVED:

(a) Amalgamation – Court's sanction to Scheme – Tenability of contention that transfer of immovable property between Companies is not transfer inter vivos and such transfer is not 'conveyance' under the Transfer of Property Act – Section 394 (2) read with Section 10 of Indian Stamp Act, 1899 and Section 5 of the transfer of property Act, 1882.

#### **DECISION**

In Hindustan Lever v. State of Maharashtra [2003] 57 CLA 56, the Supreme Court held that an approved Scheme of Amalgamation amounts to transfer inter vivos between two Companies which were juristic persons in existence at the time of passing of the order and sanctioning of the Scheme whereby the right, title and interest in the immovable property of the transferor Company are transferred to the transferee Company in the present and the transfer is not postponed to any later date, and the same is covered under the definition of 'conveyance' under clause (10) of Section 2 of the Stamp Act.

(b) Amalgamation – Court's sanction to Scheme – Transfer of immovable property from Transferor Companies to Transferee Company – How far exigible to stamp duty – Section 394(2) read with Indian Stamp Act, 1899

#### **DECISION**

For the purposes of imposition of stamp duty, it would be immaterial as to whether the conveyance was by operation of law, statutory operation or by virtue of private contract between the parties, because exemption has to be by specific statutory provisions. Hence, the order approving the Scheme for amalgamation passed by the Company Court in exercise of jurisdiction under sub-section (2) of Section 394 which has the effect of transferring of all assets and liabilities including the property of the transferor company to the transferee company would be exigible to stamp duty under the Indian Stamp Act.

He also explained in detail the valuation methodologies viz. multiples based, asset valuation and income approach with the help of examples.

Mr. Vinod Jain, Chairman INMACS Management Services Ltd. spoke on the topic "Financial and Accounting aspects of Corporate Restructuring". He discussed that the need for restructuring may be for tax efficiency, unlock value, pre IPO, Balance Sheet resizing, acquisition, joint venture etc. He discussed the various modes of restructuring. He also discussed in detail the provisions as well as accounting aspects relating to merger, demergers, takeover, buyback, and subsidiarisation.

Mr. Ashutosh Chaturvedi, Executive Director, PricewaterhouseCoopers Pvt. Ltd spoke on the topic "Commercial and Tax aspects of Corporate Restructuring". He said that restructuring is pervasive; it is the need of every business. He discussed in detail the requirement of restructuring. It may be structuring for fund raising, structuring for overseas listing, acquisition and funding structuring, profit repatriation and streamlining promoter shareholding.

The RD will give a Compliance or non compliance affidavit to the High Court. He explained in detail the entire process followed in the office of Regional Director after filing of the scheme.

He explained the procedure as to how does a dead-like company can move out of the corporate system.

Miss Neha Gupta, who bagged All India Rank 2<sup>nd</sup> in the Professional Course Dec. 2009 Examination, was honoured by a memento of "Meritorious Student" from Agra Chapter, which was awarded to her by the Chief Guest, Dr. Navrang Saini.

The amount of penalty must be paid within 15 days from the date of receipts of letter or RBI's reply. RBI has imposed the highest fine for ECB related violation. He said a Company Secretary must be careful, while filing form RF-GPR. He also

proclaimed foreign exchange market and its related regulations as on allowing field for professionals and still to be tapped fully.

Thereafter, Mr. B.K. Sharma, Chairman, NIRC-ICSI and General Manager, Delhi Stock Exchange, brushed up the knowledge regarding 'Securities Laws- SEBI (ICDR) Regulations & SME Stock Exchange –SEBI Guidelines. He provided relevant information relating to these latest SEBI Guidelines and the current amendments pertaining thereto.

Juneja, started the session with Company Law Settlement Scheme 2010 and informed the members that the Ministry of Corporate Affairs introduced Company Law Settlement Scheme (CLSS) - 2010 under General Circular 1/ 2010 dated 26th May, 2010 to grant immunity against prosecution for non-filing of documents. The MCA has launched CLSS 2010 due to default by a large number of Companies in filing of documents with ROC. Resultantly, records in e-registry are not updated and hence not available to public for inspection. In the normal course, Companies attempting to correct the default by filing documents is burdened with additional filing fee and is also liable to be prosecuted under the Act. Therefore, in order to facilitate Companies to streamline their documentation process with e Registry, MCA introduced the scheme namely, CLSS 2010 which commenced on 30th May, 2010 and will be applicable till 31st August, 2010. The Companies, which will avail CLSS 2010 with get the benefit of condonation on delay in filing of documents, immunity from prosecution and have to pay only 25% of additional filing fee.

Thereafter, Mr. Juneja deliberated upon Easy Exit Scheme 2010 issued by MCA vide circular no 2/2010 effective from 26<sup>th</sup> May, 2010 to 31<sup>st</sup> August, 2010. The scheme is applicable for the Companies registered under Companies Act, 1956 which are not carrying on any business activity or operation on or after 1<sup>st</sup> April, 2008 and includes Companies which have not raised their paid-up capital to minimum prescribed. The Companies applying under the scheme must have status as "Active". Government defunct Companies can also avail the benefit of EES 2010 but need to submit NOC issued by concerned Administrative Ministry or State Government or Department.

Session was very informative and interactive. Mr. Juneja satisfactorily replied to various queries raised by members in respect of CLSS & EES 2010.

At the end, the convener Ms. Meenu Juneja thanked the speaker on the behalf of the study circle group for making detailed presentation covering all aspects of both the Schemes including the reasons and benefits of issuing the Schemes.

#### Company Law Settlement Scheme, 2010

He said that CLSS -2010 is the Second Scheme granting immunity against prosecution for non-filing of documents under General Circular 1/2010 dated 26 May 2010. This scheme commences on  $30^{th}$  May, 2010 and valid upto  $31^{st}$  August 2010.

He explained the reasons for bringing this scheme into effect.

Then he explained the benefits of CLSS. He explained the procedure for availing this scheme and consequences for not availing it.

#### **Easy Exit Scheme**

He said that this scheme is also valid from 30May 2010 to 31<sup>st</sup> August 2010. He explained that who can and who cannot avail this scheme. He also explained its procedure and consequences for not availing the scheme.

At the end, members asked their queries on the above subject and speaker removed their doubt.

The meeting was over with a vote of thanks to Mr. Sanjay Sood.
