# Recession of Circular relating to creation, modification and satisfaction of charges

During the transition period of switching over from manual filing to e-filing (through MCA-21), an order was passed by the Company Law Board (CLB) on August 3, 2007 authorizing the Central Government to accept documents relating to registration, modification and satisfaction of charges up to a period of 300 days from the date of event by levying additional fee prescribed in Section 611(2) of the Companies Act, 1956 (the 'Act') i.e., not exceeding 10-times the amount of fee specified in Schedule X. Thereupon, the Ministry of Corporate Affairs (MCA) issued General Circular No.13/ 2007 dated September 27, 2007 and made the above CLB order was made effective from October 27, 2007.

Consequent to the Central Government's application seeking for permission to withdraw the said Circular, the CLB has vide Order dated May 7, 2008 allowed the Central Government to withdraw the same and reinstate the position as it stood prior to October 27, 2007.

The MCA has now issued a fresh General Circular No. 1/2008 dated July 1, 2008, which provides that the documents filed on the portal (*www.mca.gov.in*), on or after July 6, 2008 for registration/ modification of the charge or for giving of intimation of payment or satisfaction thereof after a period of 60-days or 30-days respectively, shall not be registered by the concerned Registrar until the delay is condoned by the CLB.

# Amendments to SEBI (Employee Stock Option Scheme and Employee Stock Purchase Scheme) Guidelines, 1999

Following amendments have been brought to SEBI (ESOS & ESPS) Guidelines:

1. Eligibility of nominee directors for ESOS –It has been decided to clarify that a director, nominated by an institution as its representative on the Board of Directors of a company, is eligible to participate in the ESOS of the company, if the contract/ agreement entered into between the nominating institution and the director so appointed specifically provides for acceptance of ESOS of the company by such director and a copy thereof is filed with the company.

**2.** Accounting treatment for options granted under graded vesting schemes —It has been decided to bring the accounting treatment prescribed by SEBI for options granted under graded vesting, in line with the accounting treatment provided by ICAI in this regard.

#### FEMA/RBI

Guidelines relating to security for ECBs

The Reserve Bank of India ("RBI") has liberalized guidelines relating to security for External Commercial Borrowing ("ECB") as under:

- 1) AD Category-I banks have been allowed to convey 'no objection' under the Foreign Exchange Management Act, 1999 ("FEMA") for creation of charge on immovable assets, financial securities and issue of corporate or personal guarantees in favour of overseas lender/ security trustee, to secure the ECB to be raised by the borrower.
- 2) Before according 'no objection' under FEMA, AD banks may ensure and satisfy themselves that —(i) the underlying ECB is strictly in compliance with the extant ECB guidelines; (ii) there exists a security clause in the loan agreement requiring the borrower to create charge on immovable assets/ financial securities/ furnish corporate or personal guarantee; (iii) the loan agreement has been signed by both, the lender and the borrower; and (iv) the borrower has obtained Loan Registration Number (LRN) from the RBI.

Rs. 7,500/-

Earners' Foreign Currency (EEFC) accounts to the extent of outstanding balances of USD 1 million per exporter. The permission was valid up to October 31, 2008 and was subject to review.

The measure has since been reviewed in consultation with the Government of India and it has been decided to withdraw the facility from November 1, 2008. Accordingly, with effect from November 01, 2008, all EEFC accounts shall only be permitted to be opened and maintained in the form of non-interest bearing current accounts.

#### **TAX LAWS**

#### **Mandatory E-Payment of Taxes**

The Central Board of Direct Taxes (CBDT), vide notification S.O. No. 493(E), dated 13.3.2008 had notified that (i) a company; and (ii) a person (other than a company), to whom provisions of section 44AB of the Income-tax Act, 1961 are applicable, are mandatorily required to pay taxes electronically, on or after 1st April, 2008.

With a view to facilitate such electronic payment of taxes, a taxpayer has been allowed to make electronic payment

of taxes from the account of any other person. However, the challan for making such payment must clearly indicate the Permanent Account Number of the taxpayer on whose behalf the payment is being made. Further, it has been clarified that the meaning of 'tax' for e-payment purposes will include payment of tax deducted at source or tax collected at source.

# Time limit for filing refund application for Additional Duty of Customs

The Government had issued notification no. 102/2007 Customs dated 14-9-2007 to grant refund of additional duties of customs to the importer-cum-trader provided the sales tax/ Value Added Tax (VAT) is paid on sale of such goods by such importer-cum-trader. The procedure for filing the refund application of 4% additional duty of customs has been prescribed in Circular No. 6/2008 dated 28-4-2008. However, there was no time limit prescribed in the said notification for filing a refund claim.

Now, the said notification has been amended vide notification no. 93/2008 dated 1-8-2008 to prescribe the time limit for filing a refund claim *within one year* from the date of payment of said additional duties of customs.

# FAQs on Competition Law

### FREQUENTLY ASKED QUESTIONS ON COMPETITION LAW IN INDIA

#### What is competition in the market?

- In common parlance, competition in the market means sellers striving independently for buyers' patronage to maximize profit (or other business objectives).
- A buyer prefers to buy a product at a price that maximizes his benefits whereas the seller prefers to sell the product at a price that maximizes his profit.

### Why do we need competition in the market?

Competition makes enterprises more efficient and offers wider choice to consumers at lower prices. This ensures optimum utilization of available resources. It also enhances consumer welfare since consumers can buy more of better quality products at lower prices.

**Fair** competition is beneficial for the consumers, producers / sellers and finally for the whole society since it induces economic growth.

#### What is meant by unfair competition?

Unfair competition means adoption of practices such as collusive price fixing, deliberate reduction in output in order to increase prices, creation of barriers to entry, allocation of markets, tie-up sale, predatory pricing and discriminatory pricing.

### What constitutes competition policy?

- Competition policy is defined as those Government measures that affect the behaviour of enterprises and structure of the industry with the view to promote efficiency and maximize welfare.
- There are two elements of competition policy:-

First, a set of policies, such as liberalized trade policy, relaxed FDI policy, deregulation, etc., that enhance competition in the markets.

Second, legislation to prevent anticompetitive practices with minimal government intervention.

### When was the competition law enacted in India?

- The Monopolies & Restrictive Trade Practices Act, 1969 is the first enactment to deal with competition issues and came into effect on 1st June 1970.
- The Government appointed a committee in October 1999 to examine the existing MRTP Act for shifting the focus of the law from curbing monopolies to promoting competition and to

suggest a modern competition law. Pursuant to the recommendations of this committee, the Competition Act, 2002, was enacted on 13th January 2003.

 It provides for different notifications for making different provisions of the Act effective including repeal of MRTP Act and dissolution of the MRTP Commission.

# Whether provision relating to repeal of MRTP Act has been notified?

• Not as yet.

# Whether all provisions of the Competition Act have been notified?

- Certain provisions such as those relating to establishment of the Commission, appointment of Chairperson and Members, appointment of staff, undertaking of competition advocacy have been notified.
- Other provisions of the Act are yet to be notified such as those relating to adjudication of anticompetitive practices and regulation of combinations.

#### What are the objectives of the Competition Act?

The objectives of the Competition Act are to prevent anti-competitive practices, promote and sustain competition, protect the interests of the consumers and ensure freedom of trade.

#### How would the objectives of the Act be achieved?

The objectives of the Act are sought to be achieved through the instrumentality of the Competition Commission of India (CCI) which has been established by the Central Government with effect from 14th October, 2003.

#### What are the functions of CCI?

- CCI shall prohibit anti-competitive agreements and abuse of dominance, and regulate combinations (merger or amalgamation or acquisition) through a process of enquiry.
- It shall give opinion on competition issues on a reference received from an authority established under any law (statutory authority)/Central Government.
- CCI is also mandated to undertake competition advocacy, create public awareness and impart training on competition issues.

#### What is an "agreement" under the Act?

An agreement includes any arrangement,

understanding or concerted action entered into between parties. It need not be in writing or formal or intended to be enforceable in law.

#### What is an anti-competitive agreement?

- An anti-competitive agreement is an agreement having appreciable adverse effect on competition.
   Anti-competitive agreements include:-
  - Agreement to limit production & supply
  - Agreement to allocate markets
  - Agreement to fix price
  - Bid rigging or collusive bidding
  - Conditional purchase/sale (tie-in arrangement)
  - Exclusive supply/distribution arrangement
  - Resale price maintenance
  - Refusal to deal

#### What constitutes abuse of dominance?

Dominance refers to a position of strength which enables a dominant firm to operate independently of competitive forces or to affect its competitors or consumers or the market in its favour. Abuse of dominant position impedes fair competition between firms, exploits consumers and makes it difficult for the other players to compete with the dominant undertaking on merit. Abuse of dominant position includes imposing unfair conditions or price, predatory pricing, limiting production/market, creating barriers to entry and applying dissimilar conditions to similar transactions.

### When the Commission may initiate enquiry into anticompetitive agreements/abuse of dominance?

- On its own on the basis of information and knowledge in its possession, or
- On receipt of a complaint, or
- On receipt of a reference

#### Who can make a complaint?

- Any person, consumer, consumer association or trade association can make a complaint against anti-competitive agreements and abuse of dominant position.
- A person includes an individual, Hindu Undivided Family (HUF), company, firm, association of persons (AOP), body of individuals (BOI), statutory corporation, statutory authority, artificial juridical person, local authority and body incorporated outside India.
- A consumer is a person who buys for personal use or for other purposes.

### Who can make a reference for an enquiry?

# FAQs on Competition Law

The Central Government or a State government or an authority established under any law may make a reference for an enquiry.

#### Can the Commission initiate enquiry on its own?

Yes, it is reiterated that the Commission can initiate enquiry on its own on the basis of information or knowledge in its possession.

### How will the Commission proceed with an enquiry?

On its own, or receipt of complaint/ reference, if the Commission is of the opinion that there is a prima facie case, it shall direct the Director General, appointed under the Act, to investigate the matter and report his findings.

### What will the Commission do after investigation?

After receipt of the investigation report from the Director General, the Commission shall adjudicate the matter after hearing the parties and pass orders as deemed fit.

### What orders the Commission can pass in case of anticompetitive agreements and abuse of dominance?

- During the course of enquiry, the Commission can grant interim relief restraining a party from continuing with anti competitive agreement or abuse of dominant position
- To impose a penalty of not more than 10% of turn-over of the enterprises and in case of cartel -3 times of the amount of profit made out of cartel or 10% of turnover of all the enterprises whichever is higher
- After the enquiry, the Commission may direct a delinquent enterprise to discontinue and not to reenter anti-competitive agreement or abuse the dominant position
- To award compensation
- To modify agreement
- To recommend to the Central Govt. for division of enterprise in case it enjoys dominant position.

#### What is a combination under the Act?

Combination includes acquisition of shares, acquisition of control by the enterprise over another and amalgamation between or amongst enterprises.

### What kind of combination is regulated under the Act?

Combination, that exceeds the threshold limits specified in the Act in terms of assets or turnover, which causes or is likely to cause an appreciable adverse effect on competition within the relevant market in India, can be scrutinized by the Commission



#### What are the threshold limits?

In case of combination the threshold limits are-For acquisition –

- Combined assets of the firms more than Rs 1000 cr or turnover more than Rs 3000 cr (these limits are US\$ 500 millions and 1500 millions in case one of the firms is situated outside India).
- The limits are more than Rs 4000 cr or Rs 12000 cr and US\$ 2 billion and 6 billions in case acquirer is a group in India or outside India respectively. For merger/amalgamation –
- Assets of the merged/amalgamated entity more than Rs 1000 cr or turnover more than Rs 3000 cr (these limits are US\$ 500 millions and 1500 millions in case one of the firms is situated outside India).
- The limits are more than Rs 4000 cr or Rs 12000 cr and US\$ 2 billion and 6 billions in case merged/ amalgamated entity belongs to a group in India or outside India respectively

# Does a firm proposing to combine have to notify the commission?

A firm proposing to enter into a combination, may, at its option, notify the Commission in the specified form disclosing the details of the proposed combination within 7 days of such proposal.

# What is the procedure for investigation of combinations?

If the Commission is of the opinion that a combination is likely to cause or has caused adverse effect on competition, it shall issue a notice to show cause the parties as to why investigation in respect of such combination should not be conducted. On receipt of the response, if Commission is of the prima facie opinion that the combination has or is likely to have appreciable adverse effect on competition, it may direct publication of details inviting objections of public and hear them, if considered appropriate. It may invite any person, likely to be affected by the combination, to file his objections. The Commission may also enquire whether the disclosure made in the notice is correct and combination is likely to have an adverse effect on competition.

# What orders the Commission can pass in case of combinations?

It shall approve the combination if no appreciable adverse effect on competition is found

# **FAQs on Competition Law**

It shall disapprove of combination in case of appreciable adverse effect on competition May propose suitable modification as accepted by parties

# Who can represent the parties before the Commission?

The parties in person or through authorized representative or through a legal practitioner or a practicing Company Secretary/Chartered Accountant/Cost and Works Accountant.

### Who can make a reference on a competition issue?

During the course of any proceeding before it, a Statutory Authority may make a reference for opinion if any party raises an issue that the decision of the authority is likely to be contrary to the provisions of the Competition Act.

# Can the Government seek the Commission's opinion on competition policy?

Yes. The Central Government, in formulating policy relating to competition, may seek opinion of the Commission by making a reference which the Commission is mandatorily required to give within sixty days from the date of reference.

### LEGAL UPDATE

[2008] 82 CLA 385 (Kar.)

# (IN THE HIGH COURT OF KARNATAKA) ASTRAZENECA PHARMA INDIA LTD., In re.

N Kumar, J 6<sup>th</sup> July, 2007

#### ISSUE(S) INVOLVED:

Whether the objections raised by the Regional Director to a 'Scheme of Arrangement' providing for issue of Bonus Debentures out of General Reserves on the ground that such issue was in violation of the provisions of Sections 205A, 77 and was otherwise not in accordance with the provisions of the Companies Act, 1956 would sustain before the Court.

#### **DECISION: HELD 'NO'**

In the instant case, the 'Scheme of Arrangement' providing for issue of Bonus Debentures upon capitalization of General Reserves was objected to by the Regional Director on the grounds that the Company was treating the Bonus Debentures as dividends and remitting the Dividend Distribution Tax amounting to Rs. 8,75,56,250/- to Revenue Authorities, therefore, the Company was declaring the dividends out of the reserves and the provisions of Section 205A (3) of the Act and the Rules made thereunder were contravened as the amount proposed to be utilized exceeded the amount prescribed under the Rules. The Company has also violated the provisions of Section 205A requiring transfer of Dividend to Special Dividend Account.

Further the issue of Bonus Debentures was against the provisions of Section 77 of the Act as the subscription to the Securities would be funded from the sources of the Company. The Company should have complied with the provisions of Section 117C of the Act providing for creation of Debenture Redemption Reserve (DRR) and the issue of bonus debentures was otherwise not permitted under Law.

It was observed that 'Section 205A applies to unpaid dividend to be transferred to 'Special Dividend Account' and, thereafter, a dividend which has been declared by the Company, but has not been paid or claimed within thirty days from the date of such declaration, the Company shall within seven days from the date of expiry of the said period of thirty days transfer the total amount of dividend which remains unpaid or unclaimed within thirty days to the

'Special Account' opened by the Company in that behalf in a Scheduled Bank to be called 'Unpaid dividend Account of the Company'.

It was observed that the amount which was sought to be converted into Bonus Debentures was not an amount declared as a dividend and unpaid to the Shareholders. Therefore, the said objection had no substance and Section 205A was not attracted to the facts of the present case.

Regarding the objection that the bonus debentures issued out of free reserves of the Company is against the provisions of Section 77 of the Act, as subscription to Securities issued by the Company was funded from the Company sources. It was noted that 'Section 77 prescribes restrictions on purchase by Company, or loans by Company for purchase of its own or its holding Company's Shares. Section 77A deals with the power of Company to purchase its own Securities'. Therefore, per se the aforesaid Sections have no Application.

Regarding compliance of the provisions of Section 117C of the Act providing for creation of DRR out of the profits of the Company every year for which the Company has requested for dispensation which was objected to by the Regional Director, the Company undertook to comply with the provisions of Section 117C by creation of DRR for redemption of Debentures.

The objection of the Regional Director that the bonus debentures that are issued out of the reserves of the Company was otherwise not permitted in Law. Therefore, the question whether there is any prohibition under the Act for issue of any bonus debentures out of the free reserves to the Shareholders was examined by the Court. The Court while relying upon the judgements of Supreme Court in Escorts Farms (Ramgarh) Ltd. v. CIT [1996] 6 SCC 357 / AIR 1996 and Gujarat High Court in Shashibala Navnitlal v. CIT [1964] 54 ITR 478 held the mechanism of issue of bonus shares or debentures is, apart from the abundance of Authority to support it, clearly based on sound principle of law. There was no legal impediment and this was a well accepted practice. The Court sanctioned the 'Scheme' subject to compliance of the provisions of Section 117C of the Act as well as sanction or approval from the concerned Authorities, if required under law.

# (IN THE GUJARAT HIGH COURT) PHLOX PHARMACEUTICALS LTD. AND ANOTHER, In re

K.A. Puj, J 28<sup>h</sup> July, 2005

#### ISSUE(S) INVOLVED:

- (a) Whether the objection raised by Regional Director to the Scheme of Amalgamation on the ground that during the pendency of reference of the Transferor Company before BIFR, the Company Court has no jurisdiction to entertain the Petition under Section 391/394 of the Companies Act, 1956, would survive.
- (b) Whether the Shareholder's objections based on Equity Subscription Agreement with Company prohibiting merger etc. would come in a way for sanctioning the 'Scheme of Amalgamation'.

#### **DECISION: HELD 'NO'**

In the instant case, sanction was sought in Petition filed under Section 391 read with Section 394 of the Companies Act, 1956 of a 'Scheme of Amalgamation' between the two Petitioner Companies. The Transferor Company had come within the ambit of Section 3 (1) (o) of the Sick Industrial Companies (Special Provisions) Act, 1985. The proposed 'Scheme' was approved unanimously by the Equity Shareholders and unsecured Creditors of the Transferor Company. CVCFL, one of the Shareholder had opposed to the 'Scheme' on the grounds that the 'Scheme' was against its interest and in breach of the Equity Subscription Agreement which prohibited any Merger, Consolidation, Re-organisation, Scheme or Arrangement or Compromise by the Company with its Creditors or Shareholders or any 'Scheme of Amalgamation' or reconstruction by the Transferor Company without its consent but CVCFL was not present at the Meeting nor did it cast any vote. Upon notice, the Central Government through the Regional Director raised certain objections, inter-alia, that no fees had been paid for the increase in Authorized Share Capital and payment of Stamp Duty had to be made, that there was no specific waiver order in respect of the Meeting of the Creditors of the Transferee Company.

The Chairman of the Court convened Meeting had in his Report observed that neither CVCFL sent any Proxy or Letter of Authorization under Section 187 (1) (a) of the Act nor any Representative of CVCFL attended and cast

vote at the said Meeting. Accordingly, in absence of any ballot from CVCFL, no cognizance of the same has been taken for purpose of counting votes for or against the resolution.

The objection raised by the Regional Director that the Transferor Company was required to make payment of fee and stamp duty on the increase in Authorised Share Capital, the Court relied upon the judgements of various High Courts holding that neither the Stamp duty nor registration fee was required to be paid on the increased Authorized Capital of the Transferee Company.

The Regional Director objected the 'Scheme' on the ground that since the Transferor Company had become the Sick Company and its reference was pending before the BIFR, in view of Sections 22 and 32 of SICA, 1985, the Court had no power and jurisdiction to sanction the 'Scheme'. It was contended on behalf of the Petitioner that suspension of legal proceedings as envisaged in Section 22 of SICA, 1985, was only in respect of Winding-up of Industrial Company or for execution or attachment of any of the properties of the Industrial Company or for appointment of Receiver. Thus, the provisions of Section 22 of SICA, 1985 did not contemplate suspension of any proceedings under Section 391 to 394 of the Companies Act, 1956.

While explaining the provisions of Sections 15 to 19 of the SICA, 1985 vis-à-vis Section 391 to 394 of the Companies Act, 1956, it was contended that since objects of both the Statutes is to provide for re-arrangement of business and to revive and or make the Sick Industrial Company more viable and efficient, as such, there is no inconsistency between the provisions of both the Statutes, therefore, there is no question of provisions of Section 32 of SICA, 1985 having overriding effect in the instant case. As such, the Court had ample power and jurisdiction to grant sanction of the Scheme under Section 391 and 394 of the Companies Act, 1956 despite the fact that the Company's reference was pending before BIFR.

The Regional Director raised the objection that the Complaint Letter from CVCFL, one of the Shareholders, wherein it has been alleged that the Transferor Company had committed a breach of the Equity Subscription Agreement and, therefore, they opposed the 'Scheme'. They have also placed their disapproval of the 'Scheme' on the ground that terms offered to them in respect of the Equity held by them in the Company were prejudicial to their interest and contrary to the obligations spelt out in the Equity Subscription Agreement entered into with them. The Court had taken a view that any such clause will be

hit by Section 28 of the Indian Contract Act, 1872 which provides that every such Agreement which is in restraint of legal proceedings was void.

Thus, having considered the detailed submissions made by the Petitioner Companies and the authorities relied upon before the Court, the Court was of the view that all the objections raised by the Regional Director were not tenable and in spirit to Sanction and that there was not much substance in those objections. Accordingly, based upon the facts and circumstances of the case, it was held (i) that neither Stamp duty nor registration fee was required to be paid on the increased Authorized Capital of the Transferee Company. (ii) That as the rights of the Creditors of the Transferee Company were not affected in any manner their consent was not necessary. (iii) That a negative covenant in the Equity Subscription Agreement between the Transferor Company and CVCFL was null and void, as under Section 28 of the Indian Contract Act, 1872, every such Agreement which is in restraint of legal proceedings was void and the Petitioner – Company could not be prevented from approaching the Court for sanction of the Scheme of Amalgamation as the Court had power and jurisdiction to entertain the Petition and sanction the 'Scheme' which had been approved by the requisite majority.

# SEMINAR ON "CORPORATE RESTRUCTURING, COMPANY PETITIONS AND ROLE OF COMPANY SECRETARIES"

On 26<sup>th</sup> July, 2008 the NIRC-ICSI organized one day seminar on the theme "Corporate Restructuring, Company Petitions and Role of Company Secretaries" at Scope Convention Centre, Scope Complex, New Delhi.

#### **Inaugural Session:**

Mr. Hitender Mehta, anchored the Inaugural Session. He welcomed & introduced the dignitaries on the dais.

Mr. P K Mittal introduced the theme of the seminar.

Mr. K C Mittal, President, Delhi High Court Bar Association expressed gratitude to Dr. Justice M K Sharma, Hon'ble Judge, Supreme Court of India and Mr. S Balasubramanian, Hon'ble Chairman, Company Law Board. He mentioned that the Company Secretaries are playing different role in a company. Their duty is not only towards Directors but it is towards the public at large.

Guest of Honour, Mr. S Balasubramanian, Hon'ble Chairman, Company Law Board, while speaking on the occasion mentioned that Companies Act has two parts legalistic & procedural. The expectations of corporates from Company Secretaries are that they should take care

all the issues. In case of Company Petitions before CLB, Pleading plays a very important role and it is the most important aspect that has to be taken care. Ineffective pleading may lead to loss of case. All material facts should be displayed, there should not be suppression and misrepresentation of the material facts. In case of adjudicating matters, 90% Company Secretaries are appearing before CLB. In case of non adjudicating matters, appointment of Advocate is necessary. He took the example of a case and discussed the provisions of oppression & mismanagement.

Chief Guest, Dr. Justice M K Sharma while speaking on the occasion said that Mergers and Acquisitions help consolidation of growth of trade, commerce and business of companies. He explained demerger with help of decided cases. He also highlighed the implications of Competition Law with special reference to International Acquisitions. He explained that Corporate Restructuring has become necessity and is the best form of survival & growth of company. He also discussed the various advantages and disadvantages of Corporate Restructuring.

Mr. N K Jain, Secretary & CEO, ICSI offered heartiest vote of thanks at the end of the inaugural session.

#### **First Technical Session:**

Ms. Ashu Gupta anchored the first technical session. She welcomed & introduced the dignitaries on the dais.

Mr. U K Chaudhary, Sr. Advocate & Past President, ICSI spoke on Demerger. While addressing the gathering he mentioned that in this economic & corporate scenario there could not be an apt topic than "Corporate Restructuring, Company petitions and Role of Company Secretaries". He explained that demerger is not defined under Companies Act, 1956 but for certain tax exemption purposes it has been defined under Income-tax Act. It is actually reverse merger. Demerger is commercial corporate decision. He explained it with the example of various case laws. He guided the gathering how to make effective Scheme of Demerger or Arrangement. He suggested that pleading must be strong and perfect and tax saving /saving of stamp duty should be accidental and not predominant in the scheme.

Mr. Pavan Kumar Vijay, Past President, ICSI spoke on Corporate Restructuring, Listed Companies: Regulatory Framework & Strategies. He explained various types of restructuring viz merger, reverse merger, demerger & reduction of capital. He also explained the Stock Exchange's role and the other formalities to be complied with while doing corporate restructuring. He explained that merger through BIFR is an effective way for the revival of sick company and the various exemptions available from SEBI Takeover Code. He discussed the various restructuring strategies. At the end, he said that restructuring offers tremendous opportunities for companies to grow & add value to the shareholders it unlocks the true potential of the company, it is the Company Secretary in the organization who has to take proactive steps from suggesting roadmap to the company till its implementation and to achieve underlined objectives of restructuring.

Mr. M S Gupta, Ex.-V.P., Hindustan Unilever Ltd. spoke on industry perspective vis-a-vis mergers/demergers. He said that mergers / demergers is a vital tool for economic growth. He said that key legislation involved in corporate restructuring is Companies Act, 1956, which facilitates compromise, arrangement or reconstruction of a business. Merger is one of the legal route for acquisition and Demerger for hiving off or disposal of business/undertaking. He discussed important pre and post merger steps. He also discussed some important issues regarding mergers/demergers.

### **Second Technical Session:**

Mr. Ranjeet Pandey anchored the second technical session.

Mr. Neeraj Kishan Kaul, Sr. Advocate, while addressing the gathering discussed the provisions of Section 397 & 398 of Companies Act, 1956 and the procedure for filing petition under these sections. He explained Oppression & Mismanagement with the help of various decided cases.

Mr. Virender Ganda, Past President, ICSI spoke on Investigation of the affairs of a Company under Section 234 to 237 of the Companies Act, 1956. While speaking on the occasion he mentioned that Central Government is the authority to appoint investigation under various situations. He explained in detail the definition of affairs of the company. He discussed in detail various instances of investigation u/s 234 of the Companies Act, 1956. He also explained the eligibility criteria for filing an application for investigation by shareholders, with relevant case studies. Findings during any proceedings before Company Law Board were also dealt with. He also explained various situations wherein CBI investigation is already in progress, where there is continuous conduct with the intention to defraud members, where a writ petition is filed, and there is cancellation of shares etc., by quoting and explaining various case studies. Comparison between Inspection and Investigation was also discussed in detail. Limitation Act and its implications were also stated. Power of Company

Law Board with regard to it being administrative, judicial or quasi judicial in nature was discussed in the end.
