COMPANY BILL, 2008 APPROVED BY CABINET -SET TO SEE THE LIGHT OF THE DAY

On August 29, 2008, the Union Cabinet approved the much awaited Company Bill, 2008 (the "Bill"), which proposes to replace the existing Companies Act 1956. This is now scheduled to be tabled in the next Parliamentary session. The salient features of the Bill are as under:

- 1. The basic principles for all aspects of internal governance of corporate entities and a framework for their regulation, irrespective of their area of operation, from incorporation to liquidation and winding up, contained in a single, comprehensive, legal framework administered by the Central Government.
- 2. Reinforcement of shareholders democracy with protection of the rights of minority stakeholders, responsible self-regulation with disclosures and accountability, substitution of government control over internal corporate processes and decisions by shareholder control.
- 3. Easy transition of companies operating under the existing Companies Act of 1956, to the new framework as also from one type of company to another.
- 4. Shares with differential voting rights to be done away with and valuation of non-cash considerations for allotment of shares through independent valuers.
- 5. Separate framework to enable fair valuations in companies for various purposes; and the appointment of valuers in this regard.
- 6. Chief Executive Officer, the Chief Financial Officer and the Company Secretary being recognized as Key Managerial Personnel.
- 7. Insider trading by company Directors or key managerial persons as an offence attracting criminal liability.
- 8. Statutory recognition to Audit, Remuneration and Stakeholders Grievances Committees of the Board.
- 9. The role, rights and duties of the auditors defined as to maintain integrity and independence of the audit process.

- 10. A single forum for approval of mergers and acquisitions, along with concept of deemed approval in certain situations.
- 11. Special Courts to deal with offences under the Bill. Company matters such as mergers and amalgamations, reduction of capital, insolvency including rehabilitation, liquidations and winding up are proposed to be addressed by the National Company Law Tribunal/ National Company Law Appellate Tribunal.
- 12. Facilitates joint ventures and relaxes restrictions limiting the number of partners in entities such as partnership firms, banking companies etc. to a maximum 100 with no ceiling as to professions regulated by Special Acts.
- 13. Revised framework for regulation of insolvency, including rehabilitation, winding up etc, in a time bound manner.
- 14. More effective regime for inspections and investigations of companies for levy of penalties. Levy of additional fee in a non-discretionary manner for procedural offences, such as late filing of statutory documents, to be enabled through rules. Defaults of procedural nature to be penalized by levy of monetary penalties by the Registrars of Companies. The appeals against such orders of Registrars of Companies to lie with suitably designated higher authorities.
- 15. A new entity in the form of One-Person Company (OPC) is being introduced.
- 16. Right to Shareholders Associations/ Group of Shareholders to take legal action in case of any fraudulent deed on the part of a company and also to take part in investor protection activities and 'Class Action Suits'.
- 17. Application of the MCA-21 to all the processes involved in meeting compliance obligations. Company processes also to be enabled to be carried out through electronic mode.

The Bill seeks to enable the corporate sector in India to operate in a regulatory environment of best international practices that fosters entrepreneurship, investment and growth. The Bill calls for shareholder democracy with protection of the rights of minority stakeholders. It aims at ushering in self-regulation in corporate affairs with disclosures and accountability.

PAY MONEY ONLY WHEN SHARES ARE ALLOTTED

Securities and Exchange Board of India ("SEBI") vide circular no. SEBI/CFD/DIL/DIP/31/2008/30/7 dated July 30, 2008 (the "Circular") has prescribed modalities for an additional mode of payment called Applications Supported by Blocked Amount ("ASBA") process for public issues through book building process.

ASBA is an application for subscribing to an issue, containing an authorization to block the application money in a bank account. The purpose of introducing the ASBA process is to enable the application money to remain in the bank account of the applicant till such period the allotment is finalized. This eliminates the refund process, unlike the present system where application money of retail investors is often blocked or is not refunded for weeks even when they are not allotted shares. ASBA is only an alternative mode of payment with the co-existing process i.e. payment by cheque. The circular also provides the eligibility criteria for an investor for availing the ASBA process and identifies the roles and responsibilities of other intermediaries' viz. registrars to an issue, merchant bankers and stock exchanges in the ASBA process. ASBA process would be supported by "self-certified syndicate banks" (SCSBs).

According to the ASBA process, retail investors would have to submit bids at the cut-off price through SCSBs in which they have their bank accounts. Thereafter, the SCSBs would accept the applications, block the funds after obtaining an authorisation from the account holder, to the extent of bid payment amount and then upload the application details in the electronic bidding system of the stock exchanges. Once the basis of allotment is finalized the SCSB shall accordingly unblock the funds and transfer the amount for allotted shares, to the issuer.

LEGAL UPDATE

[2008] 85 CLA 231 (Del.) (IN THE HIGH COURT OF DELHI) KRISHNA TEXPORT INDUSTRIES LTD.

v. D C M LTD.

Sanjay Kishan Kaul & Mool Chand Garg, JJ 23rd May, 2008

ISSUE(S) INVOLVED :

Whether the Company Court does not have power to stay commencement or continuation of any suit or proceeding against the Company and its Directors under Section 138 of the Negotiable Instruments Act or prosecutions under Income Tax Act, 1961 or Foreign Exchange Control Act or other Criminal Proceedings when there is a proposal for compromise or arrangement under Section 391 of the Companies Act, 1956 with Creditors or members of the Company under Court's consideration as the words 'proceedings' or 'other proceedings' used in all the aforesaid provisions must be construed ejusdem generis with the expression 'suit' which clearly implies civil proceedings and it is only such construction which is in conformity with the intent of the Legislature introducing these provisions in the Act.

DECISION: HELD 'YES'

Power of Company Court to stay commencement or continuation of any suit or proceeding against the Company in terms of sub-section (6) of Section 391 after an application is made to it under that Section has to be exercised strictly in the situation envisaged by the Legislature, that is when the proposal for Compromise or Arrangement with Creditors or Members of the Company is under consideration and there is reason to take a different view than what is taken in the context of Sections 442 and 446 of the Act.

The words used in all the aforesaid provisions of 'Proceedings' or 'other proceedings' must be construed ejusdem generis with the expression 'suit' used aforesaid and clearly imply civil proceedings. It is only such construction which is in conformity with the intent of the Legislature introducing the provisions in the said Act. It was also fortified by the views expressed by the Supreme Court in BSI Ltd.'s case while dealing with the same provision of Section 138 of the Negotiable Instrument Act and the question whether these proceedings have to be stayed in view of the Orders passed in Section 22 (1) of SICA. It can thus, hardly be expected that the provisions of Section 442 and 446 of the Act, or for that matter Section 391 of the said Act, can be interpreted in a manner so as to bring the proceedings under Section 138 of the Negotiable Instrument Act to a stand still. Thus, even if in a 'Scheme' which was approved and it was envisaged that certain amounts have to be paid, the Debtor Company or its Directors cannot insist that the proceedings under Section 138 of the Negotiable Instrument Act be quashed.

The observations made in Para 11 in the case of Jose Anthony Kakkad v. Official Liquidator [2000] 38 CLA 70/[2000] 100 Comp Cas 811 (Ker.) are of direct relevance wherein it was held that the provisions of the Special Statute, namely the Negotiable Instrument Act would have an overriding effect over the general principles of the Act and that the Criminal Proceedings as in the case of Section 138 of the Negotiable Instrument Act which were in respect of the Assets of the Company would end in the conviction or acquittal of the accused, cannot be stayed under the Act.

The matter may also be looked into from another perspective. The Company Court cannot call before itself the proceedings under Section 138 of the Negotiable Instrument Act and quash the proceedings. The power to quash those proceedings rest only with the hierarchy of the Criminal Courts. Thus, what would be the intent to put such proceedings in abeyance by an Order of a Company Court when the Company Court itself has no power at any stage to bring to an end those proceedings. It can hardly be said that the Object of Section 391 (6) of the said Act is to prevent action against the Officers of the Company who may be involved in cheating, criminal breach of trust, mis-appropriation, forgery and for that matter dishonour of cheque. Again the provision cannot be used to bring to an end a prosecution arising from Income tax Act or Foreign Exchange Control Act.

Thus, the Division bench set aside the Order of the Single Judge holding that Section 391(6) of the said Act does not envisage either quashing or stay of criminal cases against athe Company or its Directors and the proceedings against the respondents under Section 138 of the Negotiable Instruments Act instituted by the Appellant could not be stayed.

[2008] 143 Comp Cas 241 (Delhi) (IN THE DELHI HIGH COURT) INTERCORP INDUSTRIES LTD. v. STATE OF DELHI AND OTHERS

ISSUE(S) INVOLVED: Whether the Complaints for failure to comply with the provisions of Sections 255 and 268 read with Section 629A of the Companies Act, 1956 filed beyond six months are liable to be quashed under Section 468(2) of Criminal Procedure Code, 1973. **DECISION: HELD 'YES'**

In the instant case, the Registrar of Companies filed complaints in October, 2001, against the Petitioner Company alleging that the Company failed to follow the mandatory



procedure of indicating the names of its Directors who were to retire by rotation and the appointment of the Managing director of the Company was in contravention of Section 268 of the Companies Act, 1956 for the years 1996-97, 1997-98, 1998-99. The Registrar of Companies contended that the alleged contravention of Sections 255 and 268 of the Companies Act, 1956, was punishable under Section 629A of the Act. The Company contested the maintainability of the complaint on the ground that the complaint was filed after the prescribed period of time in terms of Section 468 (2) (a) of the Code of Criminal Procedure, 1973, and that there was no material to substantiate the complaints.

It was observed that the phraseology of Sections 255, 256 and 268 are indicative of the legislative intention that contravention of these provisions constitute separate offences having regard to the circumstances. The company admittedly filed its Annual Report in August, 1998, with the Registrar. The complaint pertains to years prior to that. Therefore, the year – wise position, as existing in the Annual Report were well known to the Registrar. Such being the case, the Registrar was within his rights to approach the Court with complaints having regard to the mandate of Section 468(2) of the Code of Criminal Procedure, within the time, i.e. six months as he was possessed of all information. The explanation about a report being supplied later, leading to discovery of facts, wears thin, because the offences relating to the directors and the managing director do not need 'discovery' - they are technical violations which can be gathered upon immediate publication of or filing of Balance Sheet or Annual Return by the Company. The Law of limitation is precisely meant to shut out stale claims and its operation cannot be suspended to await 'discovery' of known facts by the person or body empowered to take action. Further, the impugned Order issuing process shows that Trial Court mechanically and in a cyclostyled format summoned the Petitioner which clearly portrays a casual approach by the Court. The Court accordingly quashed the complaints.

[2008] 144 Comp Cas 109 (Cal) (IN THE CALCUTTA HIGH COURT) SREI INFRASTRUCTURE FINANCE LTD. AND ANOTHER., In re. Patherya, J

28th January, 2008

<u>ISSUE(S) INVOLVED:</u>

Whether the objections raised by the Central Government to a Scheme of Arrangement on the ground of avoidance of Capital Gains Tax and consideration and terms of License being unfair to the Shareholders would come in a way of sanctioning the Scheme by the Court which had been approved by majority Shareholders.

DECISION: HELD 'NO'

In an application for Sanction of a Scheme of Arrangement, advertisement was issued and Meetings of the Shareholders of the Transferor and Transferee Companies were held. The Scheme of Arrangement was passed unanimously without any modification in the Meetings of the Shareholders. The Central Government on issue of notices raised two objections, (i) that no time limit had been fixed for payment of consideration and the consideration was nothing but outright sale which would attract Capital Gains Tax and to avoid payment of Capital Gains Tax, the Application had been filed; and (ii) that the agreed terms of the rights, privileges and benefits to be licensed by the Transferor Company to the Transferee Company had not been spelt out and were unfair to the Shareholders of the Petitioner Companies.

Legal Update

It was noted that there was compliance with provisions of Sections 391 and 393 of the Companies Act, 1956. Meetings of the Shareholders have been held and in each Meeting the 'Scheme' has been approved unanimously without any modification. Advertisements have also been published and thereby the public at large including the Shareholders were informed of the 'Scheme of Arrangement' between the Transferor and Transferee Companies. In spite of wide publication, no Shareholder had come forward to challenge the 'Scheme of Arrangement' or to raise any objection in respect thereof. The Central Government's main objection was in respect of consideration and terms on which the license was given being not specified in the 'Scheme'. However, the consideration per se cannot invalidate the 'Scheme' as avoidance by the Company of its tax liabilities would attract the provisions of the Income tax Act, 1961 and as such, the Companies cannot escape from their respective liabilities.

It was observed that:-

'The 'Scheme of Arrangement' is an Arrangement to conduct the business of a Company by its Shareholders. The Shareholders having agreed to conduct the management and the affairs of the Company in a particular way must be honoured. The reason for doing so is that the Shareholders today were well equipped and have the prowess to evaluate the pros and cons of the functioning of the Company. Thus, they are enlightened and astute businessmen who are prudent in business management. They have their own interest and the interest of the Company in mind. The 'Scheme of Arrangement' which is just, fair, reasonable and commercial will be approved by them and none else'.

Thus based upon the findings of the case, it was held that there had been due compliance with Section 391 and Section 393 of the Companies Act, 1956 as the 'Scheme of Arrangement' had been approved and passed by the requisite majority. It cannot be said that the Scheme of Arrangement is unfair, unreasonable or fraudulent to its Shareholders, therefore, there was no reason to interfere with the decision of the Shareholders of the Companies and the Objections raised by the Central Government were not sustainable.

FAQs on Environmental Laws

FREQUENTLY ASKED QUESTIONS ON ENVIRONMENTAL LAWS

What are the laws enforced by of the Pollution Control Boards?

- A: The Central and State Pollution Control Boards were set up for enforcement of the Water (Prevention & Control of Pollution) Act, 1974. Over the years, the Boards have been assigned additional responsibilities which include the following:
 - Water (Prevention & Control of Pollution) Cess Act, 1977
 - Air (Prevention & Control of Pollution) Act, 1981
 - Environment (Protection) Act, 1986 and Rules made thereunder
 - Hazardous Waste (Management & Handling) Rules1989
 - Manufacture, storage and Import of Hazardous Chemicals Rules, 1989
 - Bio-medical Waste (Management & Handling) Rules, 1998
 - Municipal Solid Waste (Management & Handling) Rules, 2000
 - Plastics wastes Rules, 1999 of Coastal Regulation Zone Rules, 1991
 - Public Liability Insurance Act, 1991

What are the different programs/ activities implemented through State Pollution Control Board?

A: State Boards are implementing following programs:

- 1. Pollution control in 17 categories of highly polluting industries
- 2. Pollution control from industries discharging waste water into rivers and lakes
- 3. Inventorization of pollution industries in the State and ensuring their compliance to the Pollution control norms
- 4. Restoration of environmental quality in critically polluted areas
- 5. Monitoring of water and ambient air quality in the States
- 6. Hazardous waste
- 7. Bio-medical and Management of Municipal Solid Wastes

Is there any legal and institutional framework to check pollution in the country?

A: Yes, India has prepared pollution abatement strategy, which include the legal framework and the Environment Authorities. **Environment Authorities:** In addition to Pollution Control Boards, 6 Environmental Authorities have been constituted under the Environment (Protection) Act 1986, including the National Environment Appellate Authority. These are:

- The Central Ground Water Authority Aqua Culture Authority
- Dahanu Taluka Environment (Protection) Authority
- Environment Pollution (Prevention & Control) Authority for National Capital Region of Delhi
- Loss of Ecology (Prevention and Payment of Compensation) Authority for State of Tamil Nadu.
- National Environment Appellate Authority, 1997

What are the 17 Categories of the major polluting industries?

A: (1) Aluminium Smelter; (2) Caustic Soda; (3) Cement;
(4) Copper Smelter; (5) Distilleries; (6) Dyes & Dye Intermediates; (7) Fertiliser; (8) Integrated Iron & Steel; (9) Tanneries; (10) Pesticides; (11) Petrochemicals; (12) Drugs & Pharmaceuticals; (14) Pulp & Paper; (14) Oil Refineries; (15) Sugar; (16) Thermal Power Plants; and (17) Zinc Smelter.

How many critically polluted areas have been identified?

A: The Central Pollution Control Board in consultation with State Pollution Control Boards has identified 24 areas in the country as critically polluted areas. These are: Bhadravati (Karnataka), Chembur (Maharashtra), Digboi (Assam), Govindgarh (Punjab), Greater Cochin (Kerala), Kala-Amb (Himachal Pradesh), Parwanoo (Himachal Pradesh), Korba (Madhya Pradesh), Manali (Tamil Nadu), North Arcot (Tamil Nadu), Pali (Rajasthan), Talcher (Orissa), Vapi (Gujarat), Visakhapatnam (Andhra Pradesh), Dhanbad (Bihar), Durgapur (West Bengal), Howrah (West Bengal), Jodhpur (Rajasthan), Nagda- Ratlam (Madhya Pradesh), Najafgarh Drain (Delhi), Patancheru Bollaram (Andhra Pradesh), Singrauli (Uttar Pradesh), Ankleshwar (Gujarat), Tarapur (Maharashtra)

What are the steps taken to control vehicular pollution?

- A: The following steps are taken:
 - 1. Establishment of Ambient Air Quality Monitoring through out India
 - 2. Notification of Ambient Air Quality Standards under Environment (Protection) Act.



- 3. Notification of vehicular emission norms for year 1990-91,1996, 1998, 2000, 2001
- 4. Improving fuel quality by phasing out lead from gasoline, reducing diesel sulphur, reducing gasoline benzene, and etc.
- 5. Introduction of alternate fuelled vehicles like CNG/ LPG.
- 6. Improvement of public transport system.
- 7. Phasing out of grossly polluting commercial vehicles.
- 8. Public awareness & campaigns.

What steps have been taken to control noise pollution in the country?

- A: 1. Ambient noise standards were notified in 1989, which formed the basis for State Pollution Control Boards to initiate action against violating sources.
 - 2. The vehicular noise standards, notified in 1990, are being implemented by Ministry of Science and Technology, to reduce traffic noise. These standards have been made more stringent vide a notification in September 2000 and will be effective from January, 2003.
 - 3. Noise standards for diesel genset were prescribed in Dec. 1998. Govt. has been pursuing with State Pollution Control Boards, generator manufacturing and major users, for implementation of these standards. Presently these standards are being revised (the MoEF is in the process of issuing notification) making it mandatory for all generator manufacturers to provide acoustic enclosure at the manufacturing stage itself. This will have a major impact on noise from DG sets.
 - 4. Noise standards for fire-crackers were developed in October, 1999. Central Pollution Control Board had carried out a compliance testing of the fire crackers available in the market and also taken up with the Department of Explosives for compliance with these standards.
 - 5. Noise standards for petrol and kerosene generator sets were notified in September, 2000, and will be effective from September, 2002. The sale of these gensets will be prohibited if not certified by the testing agencies, identified for the purpose.
 - 6. The Noise Rules, 2000, regulates noise due to Public Address System/ Loud speakers and also prescribed procedures for noise complaint handling.

FAQs on Environmental Laws

7. Central Pollution Control Board has taken up a study on aircraft noise monitoring in Indira Gandhi International Airport, Delhi. This will be followed by development of guidelines/ standards for aircraft noise.

What steps have been taken to control noise pollution due to fire crackers?

A: The Govt. of India has enacted noise standards for fire-crackers vide G.S.R.682(E), dated 5th October, 1999, in an effort to control noise pollution due to fire crackers Recently in March 2001, Central Pollution Control Board in association with National Physical Laboratory (NPL), Delhi initiated a study on measurement of noise levels of firecrackers available in the market. The study indicates that 95% of the fire-crackers samples exceed the prescribed noise limits. Consequently, CPCB issued notice under Section 5, of the Environment (Protection) Act, 1986 to the Department of Explosives, Nagpur, to take immediate steps to control manufacturing of fire-crackers exceeding the prescribed limits. All the State Pollution Control Boards/ Committees were also requested to initiate steps to control sale of fire-crackers exceeding the notified limits, in consultation with their respective local administrations.

What steps have been taken to control noise pollution due to loud-speakers?

A: The Govt. of India has enacted Noise Pollution (Regulation and Control) Rules, 2000 vide S.O.123(E), dated 14th February, 2000. The Rule deals with provisions to control noise pollution due to loudspeakers and public address system, as given below:

Restriction on the use of loud speakers/ utility address system:

- 1. A loud speaker or a public address system shall not be used except after obtaining written permission from the authority.
- 2. A loud speaker or a public address system shall not be used at night (between 10.00 p.m. to 6.00 p.m.) except in closed premises for communication within e.g. auditoria, conference rooms, community halls and banquet halls.

What steps have been taken to control noise pollution from generator sets?

A: The Central Pollution Control Board, in association



with the Indian Institute of Science, Bangalore, had developed systems for control of noise pollution from diesel generator sets as well as from petrol/kerosene generator sets. Based on this, the noise standards for diesel and petrol/ kerosene generator sets have been developed and notified

What are the specific functions of the Pollution Control Boards?

A: Functions of Central Pollution Control Board:

- Advise the Central Government on matters relating to pollution;
- Coordinate the activities of the State Boards;
- Provide Technical assistance to the State Boards, carry out and sponsor investigations and research relating to control of pollution;
- Plan and organize training of personnel;
- Collect, compile and publish technical and statistical data, prepare manuals and code of conduct.
- To lay down standards;
- To plan nation wide programme for pollution control.

Functions of the State Pollution Control Boards

- To advise the State Government on matter relating to pollution and on siting of industries
- To plan programme for pollution control;
- To collect and disseminate information;
- To carry our inspection;
- To lay down effluent and emission standards;
- To issue consent to industries and other activities for compliance of prescribed emission and effluent standards

FAQs on Environmental Laws

Whether State Pollution Control Boards/ Pollution Control Committees are following uniform rules/ procedures for implementation of pollution control rules.

A: State Pollution Control Boards have framed rules as per approval of State Governments. More or less, procedure and rules followed by State Pollution Control Boards are similar.

SEMINAR ON DECODING THE TAKEOVER CODE-RECENT CASE STUDIES

On 30th August, 2008, the NIRC-ICSI organized one day seminar on the theme Decoding the Takeover Code-Recent Case Studies at Hotel Intercontinental Eros, Nehru Place, New Delhi.

First Technical Session :

Mr. Hitender Mehta, Chairman, NIRC-ICSI anchored the first technical session. He welcomed and introduced the dignitaries on the dais. He also briefly informed the gathering about the structure of the entire program.

Mr. Gopalkrishnan, General Manager (Listing), Bombay Stock Exchange discussed the various disclosure requirements prescribed under the SEBI Takeover Code. He also mentioned that non-compliance of disclosure norms would be treated as violation under the Listing Agreement as well as Takeover Code.

Mr. Santosh Shukla DLA, SEBI discussed the various exemptions available under Regulation 3 of SEBI Takeover Code. He also discussed the categories of exemptions available under the Regulations. He also explained the various reporting requirements provided under the Regulations.

Mr. R S Loona, Managing Partner, Alliance Corporate Lawyers, discussed the role of Takeover Panel and availability of reports to takeover panel. He mentioned that application for applying for exemption should be sent to the Regulator before acquisition the shares. He also informed the procedure of disposal of application filed with the Regulator.

Ms. Preeti V. Arora, Manager (Investment Banking), Corporate Professionals (I) Pvt. Ltd., gave a live demo of the site <u>www.takeovercode.com</u> (Knowledge Partner) and also appraised the gathering about the various facilities offered by this site.

Mr. Atul Mittal, Secretary, NIRC-ICSI offered heartiest vote of thanks at the end of the session.

Second Technical Session :

Mr. G P Madaan, Program Coordinator anchored the second technical session.

Mr. Bomi F. Daruwala, Partner, Vaish Associates, Advocates discussed the deal of Daiichi Sankyo-Ranbaxy takeover transaction. He discussed various complex issues involved in the transaction and shared practical tips to deal with such situations.

Mr. Sanjay Asher, Partner, Crawford Bayley & Co., Advocates discussed about Idea-Spice Communication deal. He also discussed in detail about the Non Compete fee related provisions under the present takeover regulations. He also discussed the concepts of "Block Deal" and "Bulk Deal".

Mr. Gautam Gupte, Sr. Vice President, Ambit Corporate Finance Pte. Ltd. discussed the Mysore Cement takeover transaction Case and deliberated on the niceties involved in the transaction.

Mr. Vijay Mehta, Managing Director, MEFCOM Capital Market Ltd. discussed the case of DCM Shriram Industries Ltd. which was first of its kind (hostile takeover). He emphasized the need for management to appropriately take care the interest of all categories of stakeholders irrespective of their share holding in the company.

Mr. Deepak Kukreja, Regional Council Member, NIRC-ICSI offered heartiest vote of thanks at the end of the session.

Third Technical Session :

Mr. Pavan Kumar Vijay, FCS, Managing Director, Corporate Professionals (I) Pvt. Ltd. spoke on Takeover Strategies. He discussed the various trigger points under the Takeover Regulations i.e. Regulation 10, 11 & 12. He also discussed the various Takeover Strategies including takeover through corporate restructuring, inter se transfer, Regulation 12, acquisition of maximum shareholding, increasing the stake without open offer, preferential allotment, reshuffling of non-promoter group etc. At the end, he discussed the issues including Zandu Pharmaceutical-Emami case study.

Mr. Santosh Shukla spoke on Default Risk Management & Recourse. He initially mentioned the various possible violations under the Takeover Code and discussed the consequences provided under Regulation 45 and also mentioned about the Directions provided under Regulation 44. He discussed the provisions relating to monetary penalty, appeal to the Supreme Court, prosecution as provided under SEBI Act and also explained the consent process as provided under the SEBI Act.

Panel Discussion :

Mr. G P Madaan acted as Moderator of the Panel Discussion. Mr. Hitender Mehta, Mr. Pavan Kumar Vijay, Mr. R S Loona, Mr. Gopal Krishnan, Mr. Santosh Shukla,

NEWS FROM STUDY GROUPS

EAST DELHI

Date: 23.08.2008

Topic: "Corporate Restructuring – Legal Issues and Valuation"

Present : Mr. Atul Mittal, Secretary, NIRC-ICSI, (Speaker of the Session), Ms Meenu Juneja, Convenor and Ms. Mandavi, Co-Convenor along with other members

Mr. Atul Mittal started the discussion with the brief introduction of objectives of corporate restructuring and the available tools for achieving the desired objectives of corporate re-structuring including mergers, amalgamations, takeovers, acquisitions, demergers, strategic alliances & slump sale. Mr. Mittal thereafter elaborated on the concepts of demerger & slump sale. He explained the members that a unit can be transferred to another Company by the way of both the options viz., demerger and slump sale but a Company should consider the pros and cons of the transaction before choosing any option from the perspective of tax implications, legal requirements, time involvement etc. He also discussed the procedural requirements and the legal issues involved in demerger & slump sale. Mr. Mittal mentioned that reduction of share capital, change of name etc, if required in lieu of restructuring can be incorporated inter alia in the demerger scheme to avoid separate approvals for such requirements.

On the issue of valuation, Mr. Mittal informed the members that valuation is not mandatory in demerger and consideration can be paid in any mode like shares, debentures or even in cash.

The entire session was very interactive & informative and members raised various queries which were suitably answered by Mr. Mittal.

NORTH DELHI

Date: 31.08.2008

Topic : Stress Management

Mr. B.S. Bhargava, Convener, briefly introduced the speaker, Mr.K.K.Gupta who was presently working as a Deputy Manager in the Company Secretariat, NTPC Limited and was a trained yoga teacher and associated

with Bhartiya Yog Sansthan and Swami Ram Devji for a long period. Initiating discussions on the stress management and a practical approach to overcome the same, he stated that stress was on account of a variety of factors like social and family circumstances ,working conditions, fast life, irregular habits and was affecting all vital parts of the body including the mind and accentuating and giving rise to problems like diabetes, depression, mental illness, irritability, heart ailments, CAD, etc. He stated that Yogaasans and Pranayamas offer a solution to reduce stress and may even eliminate it. Yog can foster a balanced muscular system, elasticity of the bones, proper circulation of blood in the body and a proper functioning of the glandular system and nervous system. It enhances our work efficiency as a result of soundness of our health. He dealt with time management, Dhyan, balanced diet and suggested taking fruit or milk once and solid food twice a day. Pulses, lentils and vegetables may be changed every now and then. Amongst asans, he laid emphasis on Shavasan a nd Vajrasan and kapalbhati and anulom-vilom as part of Pranayam and gave practical demonatration of some important asans and pranayamsHe also advocated reading and imbibing precepts and teachings of Bhagvad Gita.to the participants and recitation of Gayatri Mantra before doing Asans and Pranayams and ending the same with the vedic prayer and shanti path.After the talk, he invited queries and questions which were answered to the satisfaction of all concerned.Mr. Bhargava thanked the speaker on behalf of all the participants for a very illuminating and useful talk.
