Technical Session:-

CS K. Sethuraman, Group Company Secretary & Chief Compliance Officer Reliance Industries Limited was the Speaker of the Whole day Session. CS Pinky Shrivastava, Treasurer, Indore Chapter of ICSI welcome chief guest & started the technical session.

In his first technical session CS K. Sethuraman, address the gathering on the SEBI (Listing obligation & Disclosure Requirements) regulations, 2015. He said that SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (Listing Regulations) have been divided into two parts. They are substantive provisions incorporated in the main body of regulations and procedural requirements in the form of schedules to the regulations.

He said that SEBI'S provisions for listed entities have been aligned with those of the Companies Act, 2013. One pertains to "passing of ordinary resolution instead of special resolution in the case of all material related party transactions subject to related parties abstaining from voting on such resolutions, in line with the provisions of the Companies Act, 2013" The latest set of norms provides broad principles for periodic disclosures by listed entities, apart from incorporating corporate governance principles.

In his second technical session CS K. Sethuraman said that Companies Act 2013. He said that main crux of new Companies act is corporate governance and as a Governance Professional we have the responsibility: not only to comply with but also to pass on a message to all the stakeholders that it has been complied in letter & spirit.

He said that it is paramount duty to ensure they perform the duty in impartial manner and ensure that there is proper compliance and governance as required by law and regulations. The Companies Act, 2013 ("The Act") is a historic legislation which has replaced existing Company Law which is 56 years old. It is a modern and contemporary law enacted after several rounds of deliberations with various stakeholders. It moves from the regime of control to that of liberalization/self-regulation. The Act contains 470 sections under 29 chapters with seven schedules.

CS Swati Bhatt, Secretary, WIRC of ICSI give vote of thanks to all the Faculties of the sessions, Delegates comes across from the region, WIRC Regional Council & Staff, Chapter Management Committee, Coordinators and all who contributed in success of the seminar.

Around 200 Members across Region are likely to participate in this Mega Seminar.

One such programme titled SEBI Listing Regulations, 2015 was organized by the ICSI in association with BSE AND Hosted by Indore & Bhopal Chapter Jointly. The location of the venue was at Hotel Lemon Tree, R N T Marg, Indore on Saturday, 12th March 2016.
